DIRECTIONS

From Pittsburgh and Kittanning Via SR-28 (Allegheny Valley Expy):

1. SR-28 to Exit 17
2. Merge onto SR-356 (north toward Butler)
3. Continue NORTH on SR-356 for 7.5 miles. (Go through five stop lights)
4. After fifth light, go approximately 1/4 mile LEFT onto Hannahstown Road
5. Church and School on Left. For School Gymnasium, park in first (larger) parking lot and enter double doors.

From Butler via SR-356:

1. SR-8 [SR-356] (South) from the top of Center Avenue hill at Sheetz
2. Continue SOUTH on SR-356 for 6.9 miles
3. Go RIGHT at Hannahstown Road (John Deere dealership on corner)
4. Church and School on Left. For School Gymnasium, park in first (larger) parking lot and enter double doors.
